### **ACCIDENTAL RELEASE MEASURES**

#### **NOTIFICATION PROCEDURES**

In the event of a spill or accidental release, notify relevant authorities in accordance with all applicable regulations.

#### **PROTECTIVE MEASURES**

#### **SPILL MANAGEMENT**
